News from Network Deployment Departments

Quality Control

Members of the department received training, and are now certified with access to the new quality tool. (The migration has been postponed until some reporting issues are resolved). After the cut, the existing quality tracking tool and the new quality tool will run in parallel for a short while.

Operational Support

Multiple finance and field workshops were held for the Change Order Process reengineering project. The process has been mapped (which includes roles and timelines) and a plenary meeting will be held in week 12.

The department has been working with the PMs and the AMs to establish measurements for the staffing models

The prestudy for the BD tool implementation started in week 10 and is expected to be completed by weeks 12 or 13.

Delivery Management

Members of the Delivery Management Department have been providing support in New Jersey..

The vendor database is almost ready for production_more details to come next month.

Business Management

Members of the department have been working with the IS department to optimize the RSS tool. These efforts resulted in an increase in speed which reduced the time PM's spend "waiting" on the tool by approximately 20 minutes/RSS.

Deena provided support to the AM in structuring SH for the UMTS project. This included customizing it for deliverable requirements for the Customer Acceptance Process, and Data Management.

Product Management & Marketing

Solution Packaging – The department has targeted to have 55 service packages completed by the end of March. The group is also participating in a process to reduce the number of RSS' in the RSS tool. The anticipated result of this clean-up is to have 153 RSS' remaining, with 180 removed from service and archived.

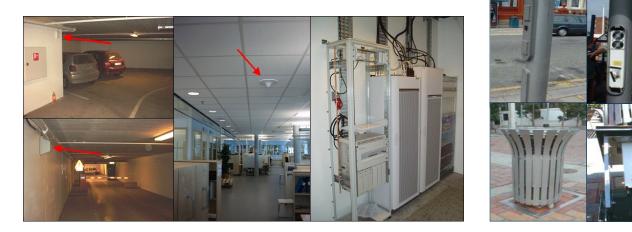
Marketing – Focus has been on one page marketing materials for Network Deployment for CTIA. Additionally, marketing materials specific for MU US have been created for our customers.

Strategic Planning – The department is also in the process of developing a local strategic plan for ND based on the requirements from the MU Services Strategic plan and the PA ND&I 2012 global plan.

Feature: In Building Solutions activities

Activities for In Building solutions are forecast to increase substantially in 2008. In the past we have done primarily small to medium sized projects in shopping malls, casinos and office buildings.

In brief, Multi-carrier and multi-band system In Building Solutions rely on Distributed Antenna Systems (DAS) to distribute wireless RF signals through low power amplifiers and antennas. The system is linked through passive and or active coaxial and fiber cables and is fed by BTS' or repeaters. A few examples of indoor as well as Outdoor DAS applications can be seen in the photographs below.

Employee profile: Gunnar

Gunnar has been with the company for 36 years. He started in the Marketing Invoicing department working to insure all of the customs requirements were met for shipment. He then moved to the installation area, and actually installed the original cross bar (all manual) switches. Based on that experience, he ran installation training courses and also acted as lead installer in Idaho. Gunnar also worked in China in 1993, Indonesia in 1996, and Belgium in 1998 before moving to the U.S. in 1999.

In his role as Quality Auditor, Gunnar conducts quality audits for both Switch and RBS installations. The auditors inspect many aspects of the quality of the installations which include the cabling, cabinets, and connectors, as well as insuring the required documentation is completed by the sub-contractor. Some examples of quality issues that can be found include; more than one grounding line connected to a single ground lug connection, screws and nuts not torqued to spec., and whether cables leaving a cable rack or entering a cabinet have abrasion protection. Most recently he conducted RBS audits in Chicago and switch expansion audits in New Jersey.
